If you have an advanced directive, please send our office a copy for your records here. **Each medical institution (hospital, doctor's office, etc.) maintains files independently.** It is necessary that **YOU** send a copy of your advanced directives to each institution (your doctor's office as well as local hospitals) where you might receive care. **Due to government privacy laws, it is illegal for our office to send or receive this information from hospitals, or for hospitals to share this information with each other or with our office. Keep a copy for yourself, and whenever you create, update, or change your advance directives, you must submit a copy to each local institution where you might possibly receive medical care. This is necessary to avoid confusion or questions in any potential urgent situation, so that your wishes are clear and always respected. Thank you.**
